

# Self-Help Homeownership Opportunity Program (SHOP)

# What is SHOP?

The Self-Help Homeownership Opportunity Program (SHOP) is an important, unique and efficient federal program. SHOP supports non-profit organizations like Habitat for Humanity that use the self-help model to acquire land, purchase foreclosed or abandoned properties and improve the infrastructure of homes for first-time, lower-income homeowners.

SHOP is administered by the U.S. Department of Housing and Urban Development (HUD) and is the only HUD grant program that provides funding exclusively for homeownership projects serving lower-income people.

As a grantee, Habitat for Humanity International competes with other national housing non-profits for SHOP awards, and U.S. Habitat affiliates, in turn, compete for the funds awarded to Habitat for Humanity International. Habitat affiliates can use up to \$15,000 in SHOP funds per home.

### Facts about SHOP:

#### • SHOP yields a significant return on investment

SHOP leverages significant private capital using minimal federal dollars. From 1996 through 2014, Habitat leveraged the \$210 million it received in SHOP funds into \$1.204 billion for community development.

# • SHOP revitalizes thousands of neighborhoods

Local businesses and jurisdictions around the country have benefited from the \$191 million in SHOP funds that Habitat affiliates have used for improvements to foreclosed and abandoned properties.

# SHOP supports lower-income homebuyers

To date, the Habitat network has housed 64,632 people and completed 17,261 homes with SHOP funds. The homebuyers were predominately below 50% AMI and now have \$429 million in equity.

#### SHOP creates job opportunities in communities

Many Habitat affiliates contract work locally to complete SHOP-funded projects, which require professional licenses or expertise. Habitat affiliates also provide job training and employment opportunities to Section 3 residents and contracting opportunities to Section 3 businesses.

#### Since 2006, Habitat's SHOP Grants have:

- Reached 3,883 Section 3 trainees\*
- · Facilitated 2,193 Section 3 new hires
- Made \$18.7 million Section 3 infrastructure contracts

<sup>\*</sup> Under Section 3 of the HUD Act of 1968, recipients of certain HUD financial assistance must, to the greatest extent possible, provide job training, employment, and contract opportunities for low-or-very-low income residents in connection with projects and activities in their neighborhoods.
