

## 2025 State of Home Affordability in Massachusetts


### In Massachusetts,




# 1 in 6 households

### spend more than half of their income on housing.

Lower-income households are especially likely to have unaffordable housing costs, requiring more than 30% of their income.






Increasingly, the typical renter can't afford to buy a home in Massachusetts.


Income needed to purchase a median-priced home

\$160,151 per year<sup>2</sup>

Median renter income \$52,600 per year<sup>3</sup>

The underproduction of housing is driving up unaffordability and impeding efforts to close racial and ethnic gaps in homeownership.
